Notes:

1) During 2017 it has become almost certain that a planning application for the issue where the NDPWG is in conflict with SDDC will be granted at a similar time to the submission of the NDP to SDDC despite the fact the PC has made a representation to the SDDC Planning Committee. It seems entirely wrong to the NDPWG that a planning application is approved for land at Burdett Way prior to formal adoption of LP part 2. These points have been made strongly to SDDC Planners (as you will note from above) and District Councillors who represent Repton and Milton on the District Council. They were reiterated at the hearing for the Local Plan.

- 2) During the latter stages of the 2017 consultation process, the PC was informed at the December meeting that no co-operation between Derbyshire County Council and SDDC over the Dales / Fisher Close will be possible.
- 3) It should be recognised the NDP was revised in 2018 with re-examination planned for 2019. The amended NDP included all the 2018 examination comments and amendments to policy H1.
